If the scope were to be widened to include texts using the latin alphabet and similar orthographies, a number of clauses(e.g. 4.5.2, 4.9, 4.10.1) would require extensive re-drafting to make them more generally applicable, which would necessitate a re-ballot of a new Draft. The UK will change its vote to APPROVAL if suitable changes are made to the title and scope clause to make the limited</p>

		applicability of the TR clear.
